Parking Control Zone Schedule

The City of Pine Springs has adopted Parking Control Regulation Ordinance 28 that promotes public safety, well-being and convenience of the residents of the City, and prevents parking nuisances on City streets. The City Council has the authority to designate specific parking zones within the City and to publish a schedule of those zone locations. This schedule is the current and sole declaration of Specific Parking Zones within the City based on the revision date.

Here are examples of how to cite control zone locations. These citations may be referenced in documents or on signs posted on city streets.

No Parking ORD 28.4.401.1.101

Resident Parking Only ORD 28.4.401.2.201

Parking Control Regulation Ordinance 28 SECTION 4.401

Subsection 1. No Parking Zones

No parked objects, as described in the Parking Control Regulation Ordinance, shall be allowed to park or stand within the designated <u>"No Parking"</u> zones of City streets described herein and subject to the provisions of the Ordinance.

- 28.4.401.1.101 <u>Hytrail Avenue N</u> "No Parking" on either side of the street from the intersection of 60th Street N and Hytrail Avenue N to the intersection of Hytrail Avenue N and Hytrail Court N.
- 28.4.401.1.102 <u>62th Street N</u> "No Parking" on the north side of 62nd Street N starting at the intersection of Hilton Trail and 62nd Street N proceeding west on 62nd Street N for two hundred fifty (250) feet.
- 28.4.401.1.103 Pinehurst Road— "No Parking Between Signs" on the north side of Pinehurst Road between ninety (90) feet west and one hundred fifty (150) feet east of the intersection with Pinehurst Court for a total length of two hundred fifty (250) feet."
- 28.4.401.1.104 <u>Viking Drive</u> "No Parking" on the north side of Viking Drive beginning at a point approximately five hundred twenty three (523) feet east of the intersection with Henna Court and extending for three hundred (300) feet west on the north side of Viking Drive.

Subsection 2. Restricted Parking Zones

Certain streets shall be designated as <u>"Restricted Parking"</u> such that parked objects may be allowed to park or stand along the designated restricted zones of the City streets described herein and subject to the provisions of the Parking Control Regulation Ordinance.

28.4.401.2.201. <u>Hytrail Court N</u> – "<u>Restricted Resident Only Parking</u>" on both sides of the street for one hundred fifty (150) feet from the intersection of Hytrail Avenue N and Hytrail Court N.

Subsection 3. Time Limited Parking Zones

Parked objects shall be allowed to park or stand along the <u>time based</u> zones of the City streets within time periods described herein and subject to the provisions of the Parking Control Regulation Ordinance.

28.4.401.3.301. <u>Pinecrest Road</u> – "<u>Restricted No Parking Sunset to Sunrise</u>" anywhere in the Pinecrest Road cul-de-sac.
